#### Road Bids

- The culvert installation bid was awarded to Fenner Excavating for an estimated cost of \$34,287.90. The work will be completed at the following locations:

  - South of East Snowmobile Trail for \$4739.96
  - 1988 South of County J on 15<sup>th</sup> Ave for \$4739.96
  - 14<sup>th</sup> Drive 1200' South of County F for \$4739.96
  - Duckcreek 1872' West of 11th Ave for \$4854.96
  - 9th Ave North of Deerborn for \$10,473.10

Motion by Bill, second by Ron to approve installation bid and estimated cost totaling \$34,287.90 Carried.
