Adams County Solid Waste – Charlie Kuhn

- Charlie will be attending our Town meetings monthly for the next year. He will provide updates related to Town wide trash and recycling collection in addition to opportunities for discussion.
- The first collection begins Tuesday, July 6th.
- Adams County Solid Waste commercial customers in the Town of Adams, previously receiving more service than what will now be offered through the Town, will be credited the difference monthly.

Adams County Planning and Zoning

Seay/Van Buren – Request to build 20x25 carport on a seasonal property located at 966 Cty Rd E. Motion by Ron, second by Bill, to approve the request. A roll call vote was taken: Jim – Yes; Ron – Yes; Bill – Yes. Motion Carried.

ATV-Aligning Town of Adams to County Ordinance

- The Town of Adams will not be adopting the Adams County Ordinance or guidelines at this time. Motion by Bill, second by Ron, that the Town of Adams will continue with our current town ordinance that is derived, in part, from WI state statutes.
- ATV/UTV Speed Limit Signs – Dave Elgin will work to have a minimum of three ATV 35mph signs posted beneath our current 45mph signs. Specifically on thoroughfares like 11th.

Insurance Renewal

Miranda to place an ad in the A-F Times Reporter requesting bids for Town insurance. Bids to be reviewed at the July 20, 2021 Town Board meeting.

American Rescue Plan Update

Miranda provided an update regarding the American Rescue Plan. The first distribution of funds will be sent electronically to the Town of Adams on or around June 25, 2021.

Any other Legal Business

- The Town of Adams will install a culvert on 7th.
- The Town of Adams received a proposal from Delmore Consulting. They have offered to complete our annual road inspections and processes for \$2500. The Town will not be utilizing their services at this time.
